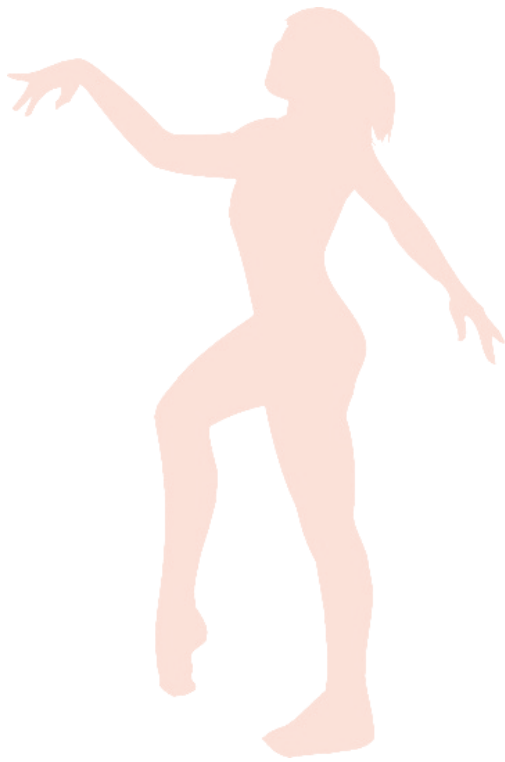

MJCCA RELEASE

This is to certify that the undersigned parent/guardian (the "Undersigned") with legal responsibility for the minor child named below (the "Minor"), does hereby consent and agree to the Minor's participation in recreational activities (including but not limited to camp, leagues, individual instruction, teams, etc.) while enrolled in the Marcus Jewish Community Center of Atlanta (hereinafter referred to as "Activities"), as well as the transportation of the Minor to or from any Activities. In connection with the Minor's participation in the Activities, the Undersigned (i) on his or her own behalf, (ii) on behalf of his or her personal representatives, heirs, next of kin, (iii) on behalf of the Minor, and (iv) on behalf of the Minor's legal guardians, heirs, next of kin:

Hereby releases, waives, discharges and covenants not to sue the Marcus Jewish Community Center of Atlanta ("MJCCA"), and all of its directors, officers, board members, trustees, employees, volunteers, agents, independent contractors and sponsors, including any agent who assists in the performance of the Activities (hereinafter referred to as the "Releasees"), for any and all loss, damage or expense to the Minor or the Undersigned, and any claim or demands therefore on account of injury to the person or property, or resulting in the death of the Minor arising out of or related to (i) the Minor's participation in the Activities, (ii) transportation of the Minor to or from the Activities, or (iii) any dental or medical assistance or treatment of the Minor, whether caused by the negligence of the Releasees or otherwise.

Hereby assumes full responsibility for any risk of bodily injury, including, but not limited to, permanent disability, death, or property damage arising out of or related to the Minor's participation in the Activities, transportation of the Minor to or from the Activities, and any dental or medical assistance or treatment of the Minor, whether caused by the negligence of the Releasees or otherwise.

Hereby acknowledges that the Activities are voluntary, involve the risk of serious injury, including permanent disability, death, and property damage.

Hereby agrees that this Release extends to all acts of negligence by the Releasees, including negligent rescue operations or procedures and is intended to be as broad and inclusive as is permitted by the laws of the State of Georgia and that if any portion of this Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

Hereby gives permission to the MJCCA and its directors, officers, employees, coaches and managers to provide routine health care and to administer any over-the-counter medications as deemed necessary by any of the foregoing.

Hereby agrees and acknowledges that he or she has read, reviewed, understands and agrees to all information on this form, as well as all the information issued by the Sports and Fitness Department., and agrees to be responsible for all fees.

Hereby authorizes the MJCCA to include the Minor's photograph, voice or other likeness in photographs, videos, printed or recorded material, including, but not limited to, use on the MJCCA website and on the internet.

By registering for this program at the MJCCA, I acknowledge that a current MJCCA membership must be maintained throughout the program season.
