Payment

A portion of your child's tuition is due at the time of registration as a deposit. The remaining tuition balance will be divided into equal monthly payments according to the payment plan schedule below. Please refer to the Registration Policies & Information for additional details.

CAMP

o Deposit: \$100 o Payment Plan: April 20, 2024 – May 20, 2024 SCHOOL o Deposit: \$300

o Payment Plan: June 20, 2024 - March 20, 2025

Payments are due two months in advance. If your child starts school after the beginning of the school year, the payment plan will commence two months in advance of your child's start date. Example: For a child starting school in November, the payment plan will commence September 20. If the due date of the first payment has passed, your first payment will be taken immediately upon the setup of your payment plan. Subsequent payments will be taken monthly ending in the month of the final payment due date listed above.

Deposits and registration fees are non-refundable and non-transferable. Tuition rates do not include membership to the MJCCA nor costs associated with Preschool Vacation Camp. MJCCA Preschools charge a credit card processing fee of 3%. For our families who prefer a payment option with no processing fee, we offer the option of electronic funds transfer (EFT).

A security fee of \$10 per month will be assessed to all non- MJCCA members.

Discounts

All discounts/credits are based on 5-day programs and are subject to review and approval before granted and issued.

Member Discount

A discount is offered for families who are year-round members of Temple Kol Emeth and/or the Marcus Jewish Community Center (MJCCA Family, Single Parent Family, or Couple memberships only), and is prorated based on enrollment date. 9- Week Camp Discount: \$100 off full day, \$50 off core day. School Discount: \$200 off full day and core day. Account must be in good standing for credit to be fully applied to school tuition.

Sibling Discount

Sibling discount of \$400 for Full Day families or \$200 for Half Day families is offered for families with more than one child enrolled in school. This is for SCHOOL ONLY - NOT offered for camp, and is prorated based on school enrollment date. Discount applied toward tuition of second and additional siblings enrolled during the 2024-25 school year. Credit will be applied directly toward school 2024-25 tuition only. Must be in attendance the entire school year and have account in good standing for credit to be fully applied to school tuition.

Referral Fee

A \$100 referral fee is available for current families who refer new families to the Weinstein School. If the new family enrolls AND attends school for the entire school year, the referring family will be awarded the \$100 credit. Credit will applied towards final tuition payment in the 2024-25 school year. In order to receive the referral credit, the name of the current family must be given to Weinstein School staff by the prospective/new family at the time of registration. Referral credit will only be issued to one named family. Multiple names on each new family referral will not be honored. MJCCA account must be good standing for referral credit to be applied.
