



ELIOT ARNOVITZ

Jewish Atlanta has never been a stranger to Eliot. His earliest education began at the Atlanta Jewish Community Center's nursery school and at the Ahavath Achim Synagogue, where he was active in youth organizations and sports.

After graduating from Henry Grady High School, Eliot received a bachelor's degree from Tulane University, where he was a leader on campus, including at his fraternity, as president of the Pan-Hellenic Council, and as yearbook sports editor. He was inducted into several honorary organizations, and upon graduation, was commissioned a second lieutenant in the United States Army and ordered to active duty.

Eliot began his career in the family real estate business, M & P Shopping Centers, where, since retiring, he remains active in strategic affairs.

Eliot has served on boards and chaired committees for the DeKalb Chamber of Commerce, American Cancer Society, Georgia Center for Children, and Civil Air Patrol. He serves as the Vice Chair of the Holly Lane Foundation and serves on the Grady Healthcare Foundation board, A Rotary Club of Atlanta member. Eliot has also held offices and served on the boards of the Marcus Jewish Community Center of Atlanta, American Jewish Committee (AJC), Ahavath Achim Synagogue, American Jewish Joint Distribution Committee, State of Israel Bonds, United Jewish Communities (now the Jewish Federations of North America), and the Anti-Defamation Legaue (ADL). He is a graduate of Leadership Atlanta, the Wexner Heritage Foundation, and the AJC's Blaustein and Adenguer Programs, Eliot is a past president of the Greenfield Hebrew Academy (now the Atlanta Jewish Academy). Center for Jewish Education and Experience, and Jewish Federation of Greater Atlanta. where he also served as interim CEO, general campaign chairman, and is now a life trustee. He is a recipient of the Abe Goldstein Human Relations Award from the ADL and the Distinguished Service Award from the AJC Atlanta Chapter.

Eliot is married to Phyllis Kozarsky, an infectious disease physician. They have four children, Kevin, Staci, Pearl, and Aaron, and four grandchildren, Maya, Cameron, Marley, and Benjamin.

Eliot enjoys tennis, golf, reading, travel, and is an avid sports fan. He is an aviation enthusiast and holds an FAA Air Transport Pilot Certificate.
