Garrett Van de Grift grew up in Miami Beach, Florida, where the JCC was a central part of his childhood. His participation in sports, teen programs, and camps had a major impact on his life, and his appreciation for the breadth and depth of the services offered to the entire Jewish community, regardless of age, affiliation, or economic capacity, stayed with him through adulthood. An active philanthropist, Garrett feels a strong sense of responsibility to give generously of his time and resources, and prioritizes his involvement with many Jewish organizations.

He is a past president of the Marcus Jewish Community Center of Atlanta (MJCCA) and is presently a board member of the MJCCA, Jewish Federation of Greater Atlanta, and Weber High School.

Garrett received his BSBA from the University of North Carolina at Chapel Hill and then his JD from the University of Florida. Upon graduating law school, he clerked for the Honorable Alcee Hastings in the United States District Court, Southern District of Florida. As his passion for law waned, Garrett pursued his aptitude for finance and secured a position at the Ford Motor Company in Dearborn, MI. After completing an MBA through the generosity of a Ford Fellowship at the University of Chicago, he pursued a career in sales and marketing at the Coca-Cola Company in Atlanta.

With the encouragement of his mentor, Ron Brill, Garrett left Coca-Cola in 1997 to start his first entrepreneurial venture. Garrett is now the CEO of Red Wizard Group, a collection of closely held companies with a diverse range of business lines: medical and healthcare, education, vending and bottling, facilities maintenance, technology and logistics, and financial services. Combined, the Red Wizard Group companies generate and manage annual sales of more than \$250 million.

Garrett is married to Rachel Dinerman, and has three children, Allie, Zachary, and Sophie.
